From the President's Pen...

Hello Folks,

I hope all is well on your end. Looks like we may have somewhat of a handle on the pandemic as cases and deaths appear to have flattened while those being vaccinated increases. I am hopeful that we have turned the corner on the pandemic and look towards getting back to 'normal,' whatever that ends up looking like...

For this article, I would like to focus on a data management artifact called 'Reference Data.' Reference Data are used for a varied number of reasons within an organization. In general, "Reference Data is any data used to characterize or classify other data, or to relate to information external to an organization" (DAMA DMBOK2, pg. 352). This Reference Data usually resides within a 'reference' table within a DBMS, although Reference Data can exist within various mediums (e.g., Excel spreadsheet.)

President's Pen, cont.

We will start with this definition and expand a little deeper. I am currently working on a project (a combination of system migration and data warehouse), and the topic of Reference Data—and the underlying 'reference' tables—has come up for discussion. The data architecture team is attempting to standardize the use and structure of reference tables throughout the organization. As part of this effort, we have drafted some basic tenets surrounding reference tables called the 3 P's: Pattern, Purpose, and Population.

Pattern refers to the general architecture, or structure, of the reference table. For example, a Common Reference pattern would consist of a 'code' and a 'description.' Whereas an Industry Reference pattern would follow the structural layout of an externally-supplied dataset (e.g., ICD codes.) An Integration Reference pattern would consist of cross-reference values to translate 'code' values from different systems/applications.

Purpose refers to the general use of the reference table. For example, a Common Reference table's *purpose* would be to provide descriptive information on a report or supply values to a dropdown list within an application. Whereas an Industry Reference table's *purpose* would be to provide a consistent set of data values to be shared across an organization. An Integration Reference table's *purpose* is to differentiate data values across applications and/or business areas and to integrate those values in context with one another.

Population refers to the general source of the data within the reference table. For example, a Common Reference table's source would be supplied by the users of the reference data, generally business areas. Whereas an Industry Reference table's source would be supplied by an external group and could not be changed within the organization using the reference data. An Integration Reference table's source would be supplied by business and data analysts working together to assure the data values are 'mapped' in proper context.

In conjunction with the 3 P's approach, all Reference Data ought to be governed in accordance with the Data Governance group to assure fit-for-purpose within the organization.

So, what do you think about the 3 P's? Does this make sense to do within your own organizations? Maybe you are already doing something similar, if so, I would like to hear about it!
