From the President's Pen...

Hello Folks,

Hope everyone had a good and enjoyable summer! As we head into Fall, there continue to be questions regarding how the DAMA chapters "fit" with DAMA International (DAMA-I) with regards to membership and CDMP certification. I'll tackle the membership item for this newsletter and the CDMP certification in a future newsletter.

In the "good ole days", membership with a local DAMA chapter guaranteed membership with DAMA-I; however, given the expansive reach of security and privacy concerns and the corresponding regulations, especially in the EU, DAMA-I has rescinded their once provided and guaranteed membership. The privacy concerns generally center around capturing PII data (Personal Identifiable Information, such as name and email address) as a result of membership. Since DAMA-I and the chapters operate as autonomous organizations, they really ought not to share PII between them.

To get around this concern, DAMA-I has put forth three types of memberships, or relationships, that us Data Geeks can establish with DAMA. They are as follows (descriptions are from our affiliation agreement for DAMA-I and DAMA Indiana):

- 1. <u>Full Affiliate Members</u>: Members who have self-registered in the DAMA-I Membership Database, remain current with annual DAMA-I membership dues payments, and who are members of a DAMA-I recognized chapter (e.g., DAMA Indiana). Full Affiliate Members must have their contact information in the DAMA-I database to have access to DAMA-I member benefits offered via the web (e.g., access to web members-only pages, DAMA-I discounts, DMBOK access, etc.).
- 2. <u>Local Affiliate Members</u>: Members of DAMA-I affiliated chapters (e.g., DAMA Indiana) who decline to register in the DAMA-I Membership Database and do not pay annual DAMA-I membership dues. These members will not have access to DAMA-I member benefits, but will have all the benefits of CHAPTER membership.
- 3. <u>DAMA-I Only Members</u>: Members who have self-registered in the DAMA-I Membership Database, remain current with annual DAMA-I membership dues payments, but are <u>not</u> members of a recognized chapter. A Full Affiliate Member whose chapter becomes unaffiliated with DAMA-I will automatically become a DAMA-I Only Member.

This biggest item of note is that a dues paying member of a local DAMA chapter (whether through an Individual or Corporate membership) would still need to pay for a separate Individual membership to DAMA-I to receive the benefits directly available from DAMA-I.

I hope this helps clear up some of the questions out there regarding membership. If not, please let me, or any of the board members know, and we'll attempt to follow up. Also, please use the chapter meetings as a forum to ask these types of questions. We want to do our best to get you the information you need to be a successful member of DAMA and, specifically, DAMA Indiana.

Thanks for your time and I hope to see you at the Fall chapter meeting!

Conference Connections


Greetings!

I recently attended my second DGIQ conference in the San Diego area and am happy to share a bit about my experience. As many of you know, the DGIQ conference is jam-packed with sessions tailored for those in the infancy of their Data Governance Programs to those with several years in and looking for ways to improve. CNO colleagues, Jo St. John and Kimberly Johnson, and I managed to attend sessions of our own interest without too much overlap. This year, I had two goals: 1) Reinforce and boost my knowledge of data governance disciplines attained from my first conference and 2) Collect information on Information Governance Principles, specifically data security and governing data for privacy standards.

On the latter, I attended several interesting sessions focused on data protection. Cisco Systems presented their view on creating a data protection program, which one can imagine is a herculean task for a global company, especially one in the business of network infrastructure equipment. I thought a few of their quiding principles were worth repeating: 1) Know thyself (the Company), 2) Leverage operational strengths (programs already operating in the business) and 3) Manage complexity and ambiguity through iterations. It's also critical to have a comprehensive team with an enterprise risk view and not a set of fractured programs.

I happened upon an unexpected gem while attending a session by Malcolm Chisolm - Metadata Management for Data Governance and Data Quality Strategy. There was much

good information packed into this session, but I will highlight one, as it is likely a relatable problem for many. The presentation included a diagram addressing SDLC vs. Data Centric Life Cycle (DLDC). The visual tells the story (below). Data centric projects do not follow the same pathway as a typical Waterfall / SDLC. Malcolm pointed out differences as in one example: In DLDC, cycles of iteration are recognized and accommodated in order to refine information requirements. This is not the case in Waterfall.



On a final note, I would add that networking during the sessions and on "Exhibit night" was an aspect of the conference I enjoyed more this year than previously; albeit, this could be attributed to not being a "first-timer". Talking about your program's challenges with other attendees is not to be under-estimated. As I experienced, conference attendees were more than happy to pass along resource links and tips related to the conversation.

On a final, final note, I heard that DGIQ will be back at the Catamaran in 2017. For

DAMA Indiana Membership Dues

Having been in the IT industry for a few years, I have found that there's one force that is 100% inevitable and is normally received with equal resistance: change.

Since the formation of the DAMA Indiana chapter in 2009, our membership policies have remained the same. We have charged the same annual fee for individual and corporate memberships and have maintained the 10-person limit on the corporate membership. Well, guess what? That's about to change. The board has met, the vote has been cast, and we now have new membership policies.

Starting in 2017, individual membership will increase to \$75 and corporate membership will increase to \$195. In addition, we will be lifting the restriction on the attendance limit on corporate memberships so that any number of employees from a company with a corporate membership can attend.


Save the Date - October Chapter Meeting
